What to Expect

What is a Tabletop Exercise?

- Discussion-based sessions where team members meet in an informal, classroom setting to discuss their roles during an emergency and their responses to a particular emergency situation
- A facilitator guides participants through a discussion of one or more scenarios

What to Expect

- Our exercise is being conducted virtually

Objectives

Core Capability: Prevention

- Identify critical objectives during the planning process
- Provide a complete and integrated picture of the sequence and scope of the tasks to achieve the objectives
- Ensure the objectives are doable within the timeframe that is part of the plan, using available resources for prevention-related plans

Objectives

- Core Capability: Protection
 - Implement risk-informed guidelines, regulations, and standards to ensure the security, reliability, integrity, and availability of
 - Critical information
 - Records
 - Communications systems and services

Outcomes

- Reveal planning weaknesses in the Emergency Operations Plan and Standard Operating Procedures
 - Test or validate recently changed procedures
- Identify current capabilities
- Improve the coordination between and among various response personnel
- Identify deficiencies and/or validate training on the critical elements of emergency response
- Increase the general awareness and understanding of the potential hazard

ACTIVE SHOOTER

Active Shooter Definition

- An active shooter by definition is an
 - individual actively engaged in killing or attempting to kill people in a confined and populated area

Active Shooter Scenarios

- Unpredictable and evolve quickly
- Often over within 10-to-15 minutes
- Typically, immediate intervention of law enforcement is required
- Staff should try to be prepared both mentally and physically to deal with an active shooter scenario

Mentality of an Active Shooter

- Desire is to kill and seriously injure
 - Not concerned for their safety or threat of capture
- Generally has intended victims and will seek them out
 - May accept targets of opportunity while searching for or after finding intended victims
- Will continue to move throughout the building/area until stopped by law enforcement, suicide or other intervention
- Will often create chaos along the way as part of their plan
 - Placing explosives or pulling fire alarms as he/she moves through the building
- Most shooters take their own life when confronted by law enforcement or resistance

How to React as Clinic Employees

- Evacuate if there is an acceptable escape path
 - Escort patients out with you if possible
 - Leave your belongings behind
- Prevent individuals from entering an area where the active shooter may be
- Follow the instructions of any police officers present
- Do not stop to assist wounded people
- Do not attempt to move wounded people
- Call 911 when you are safe

Where to Hide

- Get out of the active shooter's view
- Silence cell phones, radios and televisions
- Lock the door or blockade the door with heavy furniture to prevent an active shooter from entering your hiding place

When Law Enforcement Arrives

- Purpose is to stop the active shooter as soon as possible
- Officers will
 - Proceed directly to the area where the last shots were heard
 - Usually arrive in groups of two or more
- Officers may be
 - Wearing bulletproof vests, Kevlar helmets or other tactical equipment
 - In patrol uniforms or street clothes
 - Armed with rifles, shotguns and handguns

When Law Enforcement Arrives

- Officers may
 - Use pepper spray or tear gas to control the situation
 - Shout commands
 - Push individuals to the ground for everyone's safety
- The first officers to arrive at the scene will not stop to help injured persons

When Law Enforcement Arrives

- Remain calm and follow the officers' instructions
 - Put down any items in your hands (e.g. bags, jackets)
 - Immediately raise your hands and spread your fingers
 - Keep your hands visible at all times
 - Avoid making quick movements towards officers
 - Avoid pointing, screaming or yelling
- Proceed in the direction from which officers are entering the premises or
- Stay in a safe place until otherwise instructed

START OF EXERCISE

Scenario

- A member of your front office, who has been with your clinic for eight years, has just had his employment terminated
- As he is escorted out of the building, he tells them they will regret treating him like this

Discussion

- Who should be informed of this behavior?
- What concerns might you have?
- What actions would you consider taking, if any, at this stage?

Update

- Two days after the employee's termination
 - A popping sound is heard within the building
 - An employee runs into your office shouting that there is a man firing a gun in the hall

Discussion

- What actions should you take?
- How are you communicating with
 - Employees?
 - Patients?
- Who is communicating?
- Who on your staff would take charge of this type of event?
- Who is responsible for contacting law enforcement?
 - What information do you relay to them

Update 2

- You decide to shelter in place in an office
- You secure the immediate area
 - The popping noises seem to be coming from your floor
 - There is yelling and screaming outside your door
 - A patient, with her child, knocks frantically on your door pleading to be let in

Discussion

- What action will you take to ensure your office remains secure?
- What will you do about the patient and her child outside the door?
- What additional concerns do you have at this time?
- Are you able to communicate with employees? How?

Update 3

- You hear someone attempting to open your office door, then several loud shots
 - After a few minutes of silence, it appears the shooter may have moved on
- For nearly an hour, there is no sound from outside your door
 - Employees are receiving calls from family members who have learned of the active shooter in your building
 - Emergency personnel can be seen outside
 - The patient tells you she wants to leave your office

Discussion

- What are your immediate concerns at this time?
- What do you tell the patient sheltering in place with you?
- Who is responsible for deciding when it is safe to leave the secure area?

Update 4

- Law enforcement personnel arrive outside your office door and direct you to evacuate the building
- Upon evacuation, your employees are cornered by news reporters asking about the experience
- Some employees do not have their car or house keys and are concerned about getting home

Discussion

- How will you account for
 - Patients?
 - Employees?
- How do you prepare your employees for the disturbing scenes they may encounter as they evacuate?

Discussion

- Who is responsible for communicating with law enforcement?
- Who is responsible for communicating with the news media?
 - What information will you give them?
 - Can you control who else the media approaches? If not, what can you do?
- How will your employees get home?
 - Will you request access back into the building?
 - If so, who would go in?

Update 5

- The shooter has been apprehended by law enforcement
- There has been one death (an employee) and several injured
- The building is designated a crime scene and is closed for a week

Discussion

- Who initiates business continuity plans?
- What else needs to be considered?
- How is information disseminated to
 - Employees?
 - Patients?

Update 6

One week later

- You are able to get back into the building and resume normal business operations
- Several employees ask for more time to emotionally recover from the event

Discussion

- Are you able to continue normal business operations using fewer staff? How?
- How will you accommodate individuals who have been emotionally traumatized by the event?
- What resources will you make available to
 - Staff?
 - Patients?
- How will you communicate your clinic's resilience to concerned clients?

END OF EXERCISE

Hotwash

- What strengths in your workplace's emergency plans did this exercise identify?
- What weaknesses in your workplace's emergency plans did this exercise expose?
- What unanticipated issues arose during the exercise?
- What gaps were identified?
- What are some high-priority issues that should be addressed?
- What are some new ideas and recommendations for improvement?

Next Steps
